4. The 2<sup>nd</sup> senior most Assistant Registrar (Non-Judicial) available at the Station shall remain in-charge for countersigning Bail order(s) / any urgent order during the exemption period of Sri Tej Pratap Shukla except on 20.11.2023 when Sri Damodar Dutta, shall do the work of countersigning Bail order(s) / any urgent order during the exemption period of Sri Tej Pratap Shukla.
5. The I/c Receiving Section shall make arrangement for receiving of important Dak / letters of this Court by their staff during the holidays.
