Heard the parties through video conferencing.

Apprehending his arrest in connection with Chhattarpur P.S. Case No.305 of 2020 instituted under Sections 279, 336, 429, 353, 414, 34 of the Indian Penal Code, Section 11 (a), (d), (e), (h), (k) of Animal Cruelty Act, Section 47, 48, 50, 52, 54, 56 of Animal Transportation Act and Section 3, 4, 5, 12, 13 of Jharkhand Bovine Animal Prohibition of Slaughter Act, the petitioner has moved this Court for grant of privileges of anticipatory bail.

Learned counsel appearing for the petitioner submits that the allegation against the petitioner is that the petitioner is the owner of a Bolero Pick Up vehicle bearing registration No. JH 03Y 7797 which was involved in transportation of bovine animals for their illegal slaughter. It is submitted that the allegation against the petitioner is false. It is then submitted that the petitioner had no knowledge about his vehicle being involved in any illegal activity. Drawing attention of this Court towards para-10 of the instant bail application, learned counsel for the petitioner submits that the petitioner has no criminal antecedent. It is lastly submitted that the petitioner is ready and willing to co-operate with the investigation of the case and to furnish sufficient security including cash security. Hence, it is submitted that the petitioner be given the privileges of anticipatory bail.

Learned A.P.P appearing for the State opposes the prayer for anticipatory bail of the petitioner.

Considering the submissions of learned counsels and the facts and circumstances stated above, I am inclined to grant privileges of anticipatory bail to the petitioner. Accordingly, the petitioner is directed to surrender in the Court of learned J.M.-1st Class, Palamau at Daltonganj within six weeks from today and in the event of his arrest or surrendering, he will be enlarged on bail on depositing **Rs.10,000/-(Rupees ten thousand) as cash security** and on furnishing bail bond of

Rs.25,000/- (Twenty five thousand) with two sureties of the like amount each to the satisfaction of learned J.M.-1st Class, Palamau at Daltonganj in connection with Chhattarpur P.S. Case No.305 of 2020 **with the condition that he will co-operate with the investigation of the case and appear before the investigating officer as and when noticed by him and furnish his mobile number and photocopy of the Aadhar Card with an undertaking that he will not change his mobile number during the pendency of the case** and subject to the conditions as laid down under Section 438(2) of the Code of Criminal Procedure.
