Sub: Invitation of sealed tender from Apple OEM Authorized Resellers/Dealers for supply of Apple IPAD Pro 11-inch 512GB Wi-Fi + Cellular (with Smart Cover and Tempered Glass and other accessories) & Apple IPAD Air 10.2-inch 128 GB Wi-Fi + Cellular (with Smart Cover and Tempered Glass) as shown in Annexure-I and Annexure-II

The Office of Central Project Coordinator(CPC), High Court of Jharkhand, Ranchi invites sealed tender from Apple OEM Authorised Resellers for supply of Apple IPAD Pro 11-inch 512GB Wi-Fi + Cellular (with Smart Cover and Tempered Glass and other accessories) & Apple IPAD Air 10.2-inch 128 GB Wi-Fi + Cellular (with Smart Cover and Tempered Glass) as per technical specifications mentioned in Annexure-I and Annexure-II on the following terms and conditions:

1. If the supplier/firm is manufacturer/authorized resellers/dealers of Apple products mentioned in the tender documents, the Certificate to this effect should be attached.
2. The tender documents shall comprise following details:
 - (a) The Technical Specification should include the detailed specifications of main equipment/item and its accessories.
 - (b)The Financial Bid should include the cost of main item/equipment/software and its accessories as mentioned in Annexure-I & Annexure-II.
 - (c) The total cost should be quoted in words as well as figures.
 - (d)The Financial Bid must be mentioned in the prescribed format as per the Annexure-III & Annexure-IV respectively only.

The bidder(s) are required to submit the downloaded tender document with the stamp and signed as acceptance of terms and conditions of the tender. Moreover, the financial bid are required to be submitted on bidder(s) letterhead with proper endorsement. Incomplete tenders, amendments and additions to tender after opening or late tenders are liable to be ignored and rejected.

3. Fax and Email quotation are not acceptable.

4. Bid/Quotations should be valid for 60 days from the tender due date. The Bid/Quotation should clearly indicate the period of delivery, warranty terms etc.

5. The bidder should have adequate facilities, trained manpower and staff for installation, commissioning and providing maintenance support service after the sales of the equipment. The bidder should provide support on a regular basis with technology/product updates under the warranty terms.

6. The Suppliers should submit copies of suitable documents in support of their reputation, credentials and past performance about the product/equipment, which they have supplied to other Government/Private Companies(s)/Organisation(s)/Institution(s).

7. The tender document must be accompanied by copy of PAN, Certificate of firm/company registration, TIN/GSTIN No.

9. The Vendor must be able to provide/supply the cited items within 30 days period from the date of the Purchase Order. In case if any delay on the part of vendor the same may be justified through email/letter. Failing the delivery/supply period by due date, EMD will be forfeited. Furthermore, on completion of the stipulated time period, Purchase Order will be cancelled and award will be given to another qualified bidder with the negotiated terms & conditions.

10. Any deviation in the material and the specifications from the accepted terms may liable to be rejected and the suppliers need to supply all the goods in the specified form to the satisfaction /specifications specified in the Purchase order and demonstrate at the their own cost.

11. The Payment will be made after supply/delivery and successful installation of the items/equipments/software at High Court of Jharkhand, Ranchi.

12. High Court of Jharkhand, Ranchi reserves the rights to accept/reject any offer in full or in part without assigning any reason thereof. Any offer containing incorrect and incomplete information shall be liable for rejection.

13. Any effort by a vendor to influence the High Court of Jharkhand's tender evaluation, tender comparison or contract/order award decisions may result in the rejection of the vendor's tender and forfeiture of the vendor's EMD.

14. The Financial Bid will be opened on 19.04.2021 at 3:00 PM in The Office of CPC, Hall No. 4, Annexe G+3 Building, High Court of Jharkhand, Ranchi-834033, JHARKHAND.

- a.) The suppliers or their authorized representative may also be present during the opening of the Financial Bid, if they desire so, at their own expenses.
- b.) Only those Financial Bids will be opened whose technical specifications are found suitable by the High Court of Jharkhand.
- c.) The High Court of Jharkhand reserves its right to select or reject any or all of the items/equipment mentioned above without assigning any reasons.

15. A demand draft of Rs. 3,00,000/- (Rupees Three Lakh Only) towards refundable EMD from a Nationalized bank/Scheduled bank in favor of "**REGISTRAR GENERAL, HIGH COURT OF JHARKHAND**" placed in a separate sealed envelope marked "**EMD FOR APPLE IPAD**" should accompany bid documents. Without the EMD the bid will not be considered.

16. The EMD of the successful bidder will be returned to them without any interest after completing the successful delivery. The EMD of unsuccessful bidders will be returned to them without any interest within thirty (30) working days after awarding the offer.

17. Successful Bidder is required to submit the **Performance Security(PBG) @ 3%** of the Contract Value in favour of **REGISTRAR GENERAL, HIGH COURT OF JHARKHAND** payable at **RANCHI** within 15 days from award of contract.

18. **All the Tender Documents shall have to necessarily include the OEM Certificate, specific to this Tender , failing which, the Tender will be outrightly rejected.**
