7. *Matters relating to decrees and their execution.*
8. *Matters of any other description.*
9. *Matters u/s 482 Cr. P.C. / 528 BNSS, 2023.*
10. *PIL matters.*

- C. (a)** Matters of urgent nature of the kind notified in which urgency has arisen during the period of vacation, shall only be taken up for hearing.
- (b)** The matters which are assigned or of the designated Bench shall not be taken up by the Vacation Bench. This is without prejudice to power of Chief Justice to direct listing and hearing of a matter before the Vacation Bench.
