#### **ELIGIBILITY & CONDITIONS:-**

- 1. Qualification: Graduate in law from a University recognized for the purpose of enrollment as an Advocate under the Advocates Act, 1961.
- Age : Above 35 years but below 45 years as on 31<sup>st</sup> January,2010 i.e. candidates born between 30.01.1965 to 31.01.1975 can apply for the said post.. The upper age limit is relaxable by three years in case of S.C./S.T. candidates i.e. candidates born between 30.01.1962 to 31.01.1975 can apply for the said post.
- Experience : More than 7 years at the Bar as a practicing Advocate after having been duly enrolled as such.

Copies of the following certificates, duly attested by a Judicial Magistrate, to be attached with the application form:-

- (i). Educational qualification.
- (ii) Enrollment certificate under the Advocates Act, 1961.
- (iii) Certificate of Experience at the Bar.

**Note**: Certificate of Experience at the Bar shall be obtained either from the Registrar General of the High Court if the applicant is practicing in the High Court or from District Judge or Chief Judicial Magistrate of the District if the applicant is practicing in Court other than the High Court, or from the President and the Secretary of the Bar Association, jointly signed by both of them and duly counter-signed by the Registrar General of the High Court of the District Judge/CJM of the District, as the case may be.

# Preliminary Entrance Test

- (1) The Preliminary Entrance Test shall consist of :

  - iv. Cr.P.C.
  - v. Evidence Act.
  - vi. Law of Contract.
- (2) The Preliminary Entrance Test shall be of 100 marks in aggregate.
- (3) Duration of Preliminary Entrance Test shall be of two hours.

#### Main Examination

(1) The Main Examination shall consist of :-

Paper – I

Part – I Language (English) - 50 Marks

(Essay, Précis, Preposition and Comprehension etc.)

#### Part – II

- (i) Procedural Law (Cr.P.C. & C.P.C.)
- (ii) Law of Evidence 50 Marks

### Paper – II

Substantive Law

100 Marks

- (i) Indian Penal Code
- (ii) Law of Contract
- (iii) Sale of Goods Act
- (iv) Law of Limitation
- (v) Transfer of Property Act
- (vi) Negotiable Instrument Act
- (vii) Law relating to Motor Vehicle Accident Claim
- (viii) Jurisprudence.

(2) Examination shall be held in two sittings. In first sitting there would be examination of paper-I, duration of which shall be of three hours whereas in second sitting there would be examination of paper-II, duration of which shall also be of three hours.

#### Viva-Voce Test

- (1) There shall be Viva-Voce Test of 40 marks.
- (2) The marks obtained in Viva-Voce Test shall be added to the marks obtained in Main Examination and the merit list shall be prepared on the basis of the marks obtained in the Main Examination and Viva-Voce both.
- (3) No candidate irrespective of the marks obtained by him in the Main Examination, shall be eligible for selection for appointment, if he obtains less than 20 marks out of aggregate of 40 in the Viva-Voce Test.

# **CONDITIONS:**

- 1. Applications shall be accompanied by the Reference testimonials from two persons certifying that they know the candidate personally and that in their opinion, he bears a good moral character, is not involved in any criminal case or any offence relating to moral turpitude and in the opinion of the References should be related to the candidate directly or indirectly.
- 2. A Demand Draft of Rs. 1000/-(For General)/ Rs. 500/- (For S.C. & S.T.) favouring Registrar General, Jharkhand High Court, payable at Ranchi.
