ELIGIBILITY & CONDITIONS:-

- 1. Only candidates / appellants of the aforementioned appeals, who were appointed by way of Direct Recruitment from Bar as Judges to preside over FTCs under the FTC Scheme are eligible to submit the application.
- 2. The eligible Candidates are required to fill-up each and every column of the application Form.
- 3. Copies of the following certificates, duly attested by a Judicial Magistrate, to be attached with the application form:-
 - (i). Educational qualification.
 - (ii) Copy of Notification pertaining to their appointment as FTC Judge.
 - (iii) Certificate of Date of Birth (i.e. Certificate of Matriculation / Higher Secondary).
 - (iv) Original certificate from a qualified Medical Practitioner that the candidate possesses sound health and is free from any disease which may be hazardous for his appointment as District Judge.

Syllabus / Selection Criteria:

- (1) The Syllabus for the Written Test of 150 marks will be notified separately.
- (2) There shall be Interview / Viva-Voce Test of 100 marks including one mark per year of service in the F.T.Cs.
- (3) The qualifying marks shall be 40% aggregate for General candidates and 35% for SC/ST/OBC candidates.
- (4) The candidates who qualify the written examination and obtain consolidated percentage, as aforesaid, shall only be appointed to the post of District Judge in the regular cadre of the Jharkhand Superior Judicial Service subject to fulfillment of all criteria as per the Jharkhand Superior Judicial Service Rules, 2001.
- (5) No candidate shall be eligible for appointment as District Judge, if he/she obtains less than the aggregate marks mentioned in aforesaid column no. 3.

CONDITIONS:

- 1. A Demand Draft of Rs. 250/- (Rupees Two Hundred and Fifty only) of a nationalized Bank favouring Registrar General, Jharkhand High Court, payable at Ranchi is required to be attached.
