The suppliers / agencies / manufacturers are requested to enclose an authority letter along with Quotation. The general terms & conditions with specification of the items are mentioned below.

GENERAL TERMS AND CONDITIONS WITH REGRD TO THE TENDER

1. Tenders have to submit in sealed cover for the supply of (25 KVA & more) and 50 (KVA or more) any reputed make silent diesel generator and accessories, including civil work for concrete foundation to mount GENSET, installation, cable laying and electrical work including supply of AMF panels & changeover switch.
2. The sealed tenders have to be submitted to "The Central Project Coordinator, E-Committee, Jharkhand High Court, Office of CPC, Above Record Room, 2nd Floor, Ranchi, 834002 on or before 1st February, 2014 (upto 17.00 hrs).

3. All the materials of foundation, shall be supplied by the supplier including metallic items like bolts, anchor plates, steel templates etc.
4. All necessary arrangements for erection of DG sets are to be made by the supplier including supply of all safety appliances and tools to workmen.
5. The diesel fuel required for initial commencement of DG Set shall be supplied by the supplier.
6. The whole work to be completed within 15 days from the date of work order issued.
7. After completion of job, supplier shall carry out the measurements of power generated and shall furnish the test report to the concerned Nodal Officers of the site.
8. Transportation including loading / unloading to the installation site will be done by the supplier. The delivery sites of DG Sets are the Civil Courts of Koderma, Godda, Chatra, Jamtara, Deoghar, Pakur, Bokaro, Tenughat, Jamshedpur, Ghatshila, Dumka, Sahibganj, Rajmahal, Simdega, Ranchi, Khunti, Dhanbad, Giridih and Hazaribagh.
9. The rates quoted against the tender shall be valid for a period 120 days.
10. The quotation must be enclosed with the following documents,
 - (i) Details of the R.C.C foundation
 - (ii) Quality Assurance Plan of manufacturers for DG Sets,
 - (iii) Catalogue of DG Set,
 - (iv) Upto-date sale tax / VAT registration
 - (v) Warranty and service conditions after the warranty period.
