Terms & conditions:

- 1. The successful firm whose tender will be approved has to submit the performance security in the form of Bank Guarantee from any Nationalized Bank in favour of Central Project Coordinator(CPC), High Court of Jharkhand for an amount @ 5% of order value before payment of BILL. The Bank Guarantee should be valid for six months beyond the fully warranty period of three years from the date of successful commissioning of all the supplied items.
- 2. If the tender is submitted by a firm other than the OEM then the vendor should furnish documents from their Principal as proof of being duly authorized supplier/dealer and

OEM's consent for providing all service support during and beyond warranty period in the name of CPC, High Court of Jharkhand, Ranchi should be attached with quotation.

- 3. The **on site comprehensive** warranty of hardware and operating system will be three years from the date of installations and it must have OEM support. An undertaking on non-judicial stamp paper is to be given by the supplier to maintain the system (Hardware and Operation System) during warranty period.
- 4. The rates should be mentioned inclusive of all taxes.
- 5. Validity of quotation should be not less than 60 days. The firm should mention clearly the schedule of delivery.
- 6. Payment will be released only after supply and acceptance Test of all the supplied items at sites and imparting training to users and furnishing of a performance bank guarantee of 5% as aforesaid. Payment shall be released on receipt of the original bills in triplicate complete in all respect and original delivery challans of all the items.
- 7. The choice of color and place of delivery of the iPad will be intimated at the time of placing supply order.
- 8. The period of comprehensive onsite warranty will be applicable from the date of installations of items.
