

# High Court of Jharkhand: Ranchi

Date: 27.10.2018

Sealed Quotations are invited from reputed firms for the Comprehensive Annual Maintenance Contract for all Hardware Items including switches installed in the District Courts of Chatra, Garhwa, Jamshedpur & Pakur and few Hardware items in the District Courts of Ranchi and High Court of Jharkhand and 10 nos of switches (L3 SWITCH, 24 Port (Cisco 3750) installed one each in District Court of Bokaro, Dhanbad, Deoghar, Dumka, Giridih, Gumla, Jamtara, Latehar, Palamau and West Singhbhum of State of Jharkhand.

The details of Hardware items with names of District Courts are mentioned in Annexure-I respectively. Other related information are mentioned below.

The Sealed quotations shall be submitted in the Office of Central Project Coordinator (I/C), Hall No-04, New Building, Near Gate No-3, High Court of Jharkhand, Ranchi in a sealed cover bearing the valid Mobile Number on the cover for contact on or before 17.11.2018 along with the terms and conditions, if any. No quotations will be entertained after the due date.

## Terms & conditions of Contract :

1. The Contract would be Comprehensive Annual Maintenance Contract i.e. including repairs and replacement of parts on site without extra payment. The firm shall use only genuine / Original Equipments Manufacturer (OEM) parts.
2. Upkeep and maintenance of the Hardware installed.
3. To provide and maintain the required drivers and additional peripherals and hardware for maintaining the equipments.
4. Support for users and troubleshooting of commercial software packages and removal of virus and re-installation of software, if corrupted.
5. Coordination with OEMs for troubleshooting of the computer and other peripherals under warranty.
6. The firm shall maintain the equipment as per manufacturer's guidelines and shall use standard OEM components for replacement.
7. Any other maintenance work to be undertaken related to the computer/peripherals.
8. The Contract will be effective for a period of one year from the date of Issue of letter awarding initially for a period of one year and may be further extended up to three

- years, renewed on year to year basis, in accordance with the requirement of the High Court, provided High Court is satisfied with the services.
9. Interested firms are hereby requested to furnish their proposals / rates through two bid systems i.e. Technical Bid and Financial Bid.
  10. The list of type and number of **Hardware items** district wise is attached at **Annexure-I**.

#### **TECHNICAL TERMS AND CONDITIONS**

1. The technical proposal should include brief profile of the company/ firm, year of establishment, organizational structure, description of methodology and work plan for performing the CAMC work.
2. The firm/company must be registered firm. The firm should produce the self-attested photocopies of documents related to allocation of Registration Number, PAN Number, GSTIN, etc.
3. The firm /company should have a previous experience in AMC of such equipments with any of the Government Department/ PSUs/ Organization /Company of maintaining not less than 100 computers or any Hardware items in each year during the last three preceding years. The company should furnish its downtime statement of previous maintenance work in any one of the Government Department/ PSUs/Organization/Company for the last three preceding years.
4. The firm /company must have service centre /workshop or Office/Branch in Jharkhand.
5. The firm company should have annual business turnover of minimum Rs.Ten Lakh or more in maintenance service only, during each of the year 2015-16, 2016-17 and 2017-18. Copy of the Balance Sheet duly certified by CA to be enclosed. The firm/company must have expertise in on-site maintenance and repair of computers, printers, server, scanner, switches and other hardware including LAN work.
6. The firm /company also must have expertise and experience in LAN troubleshooting. The bidder should have executed satisfactorily Annual Maintenance of 50 or more computers connected in LAN under Novel / Window environment for two years. A performance Certificate to this effect from atleast any one Dept. / Public Sector Undertaking/Organization shall be furnished.
7. The replacement of any part of the computer/peripherals, whenever required, must be carried out by the vendor with genuine part of same specification and warranty.

8. The Technical Bid has to be accompanied by an Earnest Money Deposit (EMD) of Rs.40,000/- (Rupees Forty Thousand) only in the form of a Demand Draft / Bank Guarantee valid for (03 months) of any Commercial Bank drawn in favour of Registrar General, High Court of Jharkhand. Quotation received without EMD will not be considered. Earnest Money received from other unsuccessful tenders will be returned without interest on demand. The security deposit will be refundable after successful completion of the contract to the adjustment of dues against the contractors.

**Note :-** It is mandatory for the bidders that they shall submit the documentary proof against each of the above requirements of Technical terms and conditions chronologically in the Technical bid as per Annexure-II.

The firms meeting the above technical terms and conditions only should apply. Financial bids of a firm who fails to fulfil the above conditions will not be considered.

**FINANCIAL TERMS AND CONDITIONS :-**

1. The financial Bid should contain the rate quoted on comprehensive basis inclusive of repairs and replacement of spare parts on site without extra payment.
2. The rates quoted should also cover the maintenance of software installation, pre-emptive action against virus spread, detection / removal of virus.
3. The rates quoted should be NET (exclusive of taxes) and no discount or free services /offers quoted will be considered. The rate should be quoted per piece of each item of hardware separately. This is to facilitate addition or removal of equipments from the list covered under the contract. For comparing quotation of different parties the total annual value will be considered for a fixed number of Hardware equipment. Final price inclusive of all charges may be given separately.
4. The firm finally selected shall deposit an amount equivalent to 5% of the total awarded contract value in the form of Bank Guarantee valid for 60 days beyond the end of CAMC period in favour of Registrar General, High Court of Jharkhand, Ranchi as performance security. The security deposit will be released after satisfactory completion of the contract.

The financial bid should contain the all-inclusive rate for the Comprehensive AMC of all the Hardware and switch items as per **Annexure-I**.

**The other terms and conditions for awarding the AMC shall be as under:**

1. The vendor will provide service engineers so that service can be given on time. Service engineers must have experience of at least three years in windows software and Linux software, maintaining computer equipments and maintenance of networking and LAN in any of the Govt/PSU Sector/organization/company etc. All engineers provided for this work shall be equipped with mobile phones to ensure their availability.
2. The firm would have proper call logging system comprising of Toll Free Number and Data Analyzing facility may be set up in 04 District Courts of Chatra, Garhwa, Jamshedpur & Pakur and one in the office of undersigned or would have specialized Licensed Software having Call logging and data analyzing facility of which Management Service has to be installed in High Court of Jharkhand /any of the districts or it may be a web based system. The Software should be capable for the management of the maintenance work.
3. The firm should have well established & functional Call centre for remote support.
4. If the firm fails to carry out repairs within 48 hours to the satisfaction of the user, a penalty @ 15% per day of the AMC cost of the item to be repaired on half yearly basis will be charged. A call report duly signed by the user should be submitted to the concerned Judge -in -Charge /Registrar of the concerned District Court and one copy be sent to the undersigned.
5. The successful bidder shall provide necessary support for maintaining virus free computer environment in all concerned District Court and help in upgrading the Software / Virus detection mechanism.
6. Immediately on award of contract, the contractor would give a report taking over all equipment (giving their configuration in working condition also). It shall be the responsibility of the firm /company to make all the equipment work satisfactorily including the hardware items including (switch, Printer, Computer system, mouse, keyboard, hard Disc, Projector) throughout the contract period and also to hand over the aforesaid items to the court in working conditions on the expiry of the contract. In case any damage on the system of the concerned district court is found, compensation which would be determined by the Competent Authority will have to be paid by the firm.
7. No advance payment in any case would be made. However, **Half-yearly payment** on pro-rata basis on satisfactorily rendering of service would be made.

8. The interested firm may submit sealed envelopes for "Technical Bid" and "Financial Bid" in a sealed cover super scribed "Quotation for CAMC of Hardware components " addressed to Central Project Coordinator (I/C) ,High Court of Jharkhand latest by **5.00 P.M on 17.11.2018.**
9. Late submission of Tenders will not be accepted. Tenders by "Telex / Telegram / Fax / E-mail" will not be accepted. Tenders may be submitted by Registered Post, Speed Post, By hand in person or by courier. However, any delay on this account shall not be accepted as reason for exception.
10. High Court reserves the right to accept or reject any or all tenders without assigning any reasons.
11. It will not be open for the contractor to refuse maintenance of any equipment which on the date of entering in contract is in working condition and is not more than six years. Equipment which are more than six years old may be brought under contract by mutual agreement.

#### **Specific Conditions**

1. The CAMC shall exclude damages due to following:
  - i. High Voltage fluctuations.
  - ii. Rat biting.
  - iii. Burnt parts &
  - iv. Natural Calamity.
2. CAMC shall cover maintenance of all hardware items Computers, Printers, Scanners etc. as a whole except Printers ribbons, cartridges, Toners & DMP head .
3. The CAMC cost is inclusive of cost of spare parts required for maintenance of all Hardware and LAN items. The spare parts should be of same make as far as possible. The spare parts should be original and genuinity of these spares has to be ascertained before installation.
4. The firm should maintain the inventory of items .
5. CAMC cost is inclusive of Data recovery from HDD in cases like accidental format, deleted files, virus problem, damages and boot sector.
6. CAMC excludes data recovery from HDD in these three special cases
  - i. Physical damages due to track failure.

- ii. Head crash
  - iii. Fire damages only. These cases have to be brought to the notice of IT division officials for ascertaining the exact cause of damage.
7. Obsolete parts have to be replaced with parts available in the market of either same or higher specifications.
  8. **Arbitration:** In case of any dispute arising between the parties (High Court, Service provider or any constituent being party to the contract directly or indirectly), the sole authority for such disputes will rest with the arbitrator appointed by the High Court.
  9. **Jurisdiction:** Failing arbitration in solving the dispute, the courts at Ranchi alone shall have the jurisdiction for resolving the dispute between the aggrieved parties (High Court, Service provider or any constituent being party to the contract directly or indirectly).

The bidders are requested to read carefully and understand the terms and conditions of maintenance contract in the foregoing paragraphs before sending their quotations. No violation of the aforesaid terms and conditions shall be permitted once High Court accepts your quotations. The technical bid will be opened on **19.11.2018 at 11:00 A.M.** in the presence of authorized representative of the bidders who choose to remain present in Office of CPC, High Court of Jharkhand, Ranchi.
