In exercise of the powers conferred upon the High Court under Sub Section (I) of Section 13 of the Code of Criminal Procedure, 1973 (Act 2 of 1974), the Executive Officers named in Column no.2 of the table given below are appointed as Special Judicial Magistrates of the 2<sup>nd</sup> Class for one year from the date of issuance of the Notification, within the territorial jurisdiction mentioned against their names in Column no. 3 of the table, to try cases under the Jharkhand Conduct of Examination Act, 2001 which they can competently try under the Code of Criminal Procedure, 1973.

These officers are also vested with the powers conferrable on a Judicial Magistrate of the 2<sup>nd</sup> Class to try summarily the cases under the Jharkhand Conduct of Examination Act, 2001 as are covered under Section 261 of the Cr.P.C.

The Officers named in column no. 2 are also conferred with the powers to take cognizance of the offences under the Jharkhand Conduct of Examination Act, 2001 which they have been

authorized to try in their territorial jurisdiction.
