No. 90 A: In exercise of the powers conferred under Sub Section (2) of Section 10 of the Bharatiya Nagarik Suraksha Sanhita, 2023, the Officers named in Column No.2 are also appointed as **Additional Chief Judicial Magistrate** for the District mentioned against their names and to vest them with all the powers of a Chief Judicial Magistrate under the Bharatiya Nagarik Suraksha Sanhita, 2023 (46 of 2023), or under any other law for the time being in force as the High Court may direct, which they will exercise only in the District/Subdivision mentioned against his name in Column No.4.


