NOTICE

Invitation to offer/ tender notice on the website of High Court of Jharkhand, Ranchi for empanelment of eligible vendors for supply of Books/ Journals/ Central Bare Acts/ Local Acts/ Govt. Publications/ Photo Copy edition (only in respect to publications of Govt. of Jharkhand)/ Back set of Journals etc.

The High Court of Jharkhand, Ranchi, hereby invites tender/quotations from publishers/ authorised/ reputed suppliers for the supply of Law Books/ Journals/ Central Bare Acts/ Local Acts/ Govt. Publications/ Photo Copy edition (only in respect to publications of Govt. of Jharkhand) etc. for supply to Judges Library and other related institutions of Judiciary.

Complete quotations, in all respects, should reach the office of Learned Registrar (Establishment) I/c, High Court of Jharkhand, Doranda, Ranchi - 834033, latest by 30.05.2018 till 05.00 PM.

The tender/ quotations should contain the following information, which are as under:-

- I. Authority Letter of Publisher(s).
- II. Publisher wise discount/ rebate in detail i.e., for Indian Edition, Foreign Edition, Central Bare Acts, Local Acts, Govt. Publication, Photo Copy Ed. & Back Set of Journals.
- III. Time period under which the books would be supplied after the order is placed.
- IV. An undertaking stating therein that the books to be supplied are original. The supplier firm(s) will replace the supplied books/journals etc. in case of any defect or misprint.
- V. The Firm previously failed to supply after receiving of orders from this court or blacklisted from any institution (s) is/ are not permitted to participate in this tender.
- VI. Experience certificate regarding supply of books from institution of repute.

And only those supplier/ firm/ firms, who fulfil all the above i.e. (I) to (VI) conditions has/ have to deposit earnest money from any nationalised bank as Demand draft of Rs.50,000/- in favour of the Registrar General, High Court of Jharkhand, Ranchi as security money.

Other Terms and Conditions of the Tender are as under:

1. The books have to be supplied within a period of 15 days for Indian Edition & 60 days for foreign Edition, from the date of order.
2. All books should be of latest edition available in the market.
3. If at any stage the books supplied are found to be duplicate, the supplier would not be entitled for any payment of the supply made and the Court would be entitled to make risk purchases at the cost and responsibility of such publisher /supplier/ firm.
4. The court reserves right to cancel the tender/ quotation at any stage/ time.
5. In case of any dispute, decision of the Hon'ble Court, shall be final and binding.

Note: No telephonic call will be entertained in this regard.
